OFFICIAL RULES FOR DUELCIRCLE MEDIA DreamHack Dallas/TwitchCon San Diego 2025 Giveaway on X, formerly known as Twitter!

NO PURCHASE NECESSARY TO ENTER OR TO WIN.

VOID WHERE PROHIBITED.

1. **Eligibility.** Subject to the additional restrictions below, the DuelCircle Media DreamHack Dallas/TwitchCon San Diego 2025 Giveaway (“Giveaway”) is open to all legal residents of the Continental United States (excluding Alaska, Hawaii, and US territories) who are [thirteen (13) years of age or older as of the date of entry or the minimum age to enter giveaway under applicable law].
